Dear Parents/Guardians:

Our school division is informing parents and guardians of James River High School (JRHS) and Botetourt Technical Education Center (BTEC) that a student has tested positive for coronavirus disease 2019 (COVID-19). We understand this news is concerning and want to share our efforts to keep students and staff safe, healthy, and in school. At this time, we have ruled out any potential exposures on either school campus. James River High School and Botetourt Technical Education Center will remain **OPEN** during this time.

We are working closely with the Roanoke and Alleghany Health Department to identify anyone who had close contact with the person while riding a bus last week from BTEC to JRHS to determine if individuals on the bus may have been exposed to the virus that causes COVID-19. The parent of any child identified as having been potentially exposed will be contacted directly by the health department and will be given guidance with regard to actions that need to be taken.

If you are contacted by the health department and your child is required to stay home for a period of time, please contact the school so we can assist with ensuring your child is provided with opportunities to continue with instruction during his/her required absence from school. If you are not contacted by the health department, you do not need to stay home or exclude yourself from activities at this time.

Parents should continue to monitor their child's health and the health of their families for [COVID-19 symptoms](#). Children with COVID-19 generally have mild, cold-like symptoms, such as fever, runny nose, and cough. Vomiting and diarrhea have also been reported in some children. Children with certain underlying medical conditions, such as chronic lung disease or moderate to severe asthma, serious heart conditions, or weak immune systems, might be at higher risk for severe illness from COVID-19. Contact your child's healthcare provider regarding any concerns.

People without symptoms do not need to seek care or be tested. Those who become ill should contact their healthcare provider. Their doctor, in consultation with public health officials, will determine appropriate care and whether testing is necessary. If your child has been exposed to or diagnosed with COVID-19, please report this to your school. This information will be kept confidential.

The areas impacted by the potential exposure were cleaned following established protocols, including the use of EPA registered disinfectants. Schools continue to utilize Center for Disease

Control and Prevention (CDC) recommendations on [Reopening Guidance for Cleaning and Disinfecting Public Spaces](#), to reduce viral transmission and keep our children and school personnel healthy and safe. Parents and family members can assist this effort by promoting healthy behaviors and following these practices:

- Stay home from school or work if sick, even if symptoms are mild.
- Wear a face covering in areas where physical distancing is difficult to maintain.
- Cover coughs and sneezes with a tissue (or sleeve), and then throw the tissue in the trash. Immediately wash your hands with soap and water for at least 20 seconds.
- Wash your hands often with soap and water for 20 seconds. If soap and water are not readily available, use an alcohol-based hand sanitizer that contains at least 60 percent alcohol.
- Avoid touching the eyes, nose and mouth with unwashed hands.
- Clean and disinfect surfaces that are often touched.
- Avoid close contact with people who are sick.
- Take care of your health overall. Stay current on your vaccinations, including the flu vaccine, eat well, and exercise to help your body stay resilient.
